

EGG DONATION JOURNEY WITH IVF SPAIN

Terms and Conditions

By filling in and sending the participation form, the participants agree to the following terms and conditions regarding the “Egg Donation Journey with IVF Spain” programme (referred as to “JOURNEY”).

- 1.** No purchase is necessary to enter or win. A purchase does not increase the chances of winning the JOURNEY.
- 2. Organisation and sponsorship.** The JOURNEY is the result of a partnership between IVF Media, the owner of the online platform Eggdonationfriends.com and the fertility clinic IVF Spain Alicante (Address: Avenida de Ansaldo, 13 – 03540 Alicante, SPAIN). Eggdonationsfriends is responsible for the JOURNEY promotion and data collection of the participants. IVF Spain Alicante is responsible for the offered fertility treatment which will take place in its facilities, with its staff and its procedures.
- 3. Eligibility.** In order to enter this contest, the participants must comply with the following conditions:
 - a. Legal. The participants have to comply with the Spanish regulation and IVF Spain protocols. For instance, they must be over 18 at the beginning of the treatment, and below 51 on the day of the transfer. They also must be married (in case of heterosexual and lesbians couples) or declare themselves as single women.
 - b. Medical. The participants will medically need to undergo a fertility treatment through Egg Donation in order to achieve a pregnancy to be eligible. The treatment must be feasible (i.e. women without womb are not eligible).
- 4. How to participate and selection process.** Entries can be made from 22nd May 2017 to 18th June 2017 only both days inclusive. In order to participate, each participant needs to fill in the form specially designed for this purpose, published online, on the website of eggdonationfriends.com.

IVF Spain will contact each participant and request a complete anamnesis and then arrange a short talk with a fertility doctor from IVF Spain through Skype. This selection process will take place until June 2017, the 30th.

IVF Spain medical team, in view of the medical history and the Skype calls, will choose the winner(s). The clinic reserves the right to select the winner(s) among all the participants without having to justify its choice. The winner announcement will take place during the first week of July 2017. IVF Spain will contact every participant by e-mail, whether they will win or not.

- 5. The Egg Donation Journey.** The JOURNEY includes the cost of the First Medical Consultation at IVF Spain (valued €200) and the Exclusive Egg Donation treatment (valued €9.700) which includes a guarantee of 3 blastocysts from an exclusive donor, individual and phenotypic matching with an anonymous donor, treatment and follow-up of the donor, echographies and hormone controls at IVF Spain, first embryo transfer, on-line follow-up from IVF Spain until week 12 of pregnancy. The JOURNEY does not include the patient’s medication, the mandatory tests for the first medical consultation, and further optional tests during the treatment as well as the mandatory vitrification of the remaining embryos.

- 6. Promotion and testimonial.** The JOURNEY will be promoted online by both eggdonationfriends and IVF Spain. Therefore, the participants accept that, if chosen as winner, they will have to share their testimonial and participate in the actions of promotion that the above mentioned platform and clinic will propose (i.e. articles, video) and publish on their communication media (including IVF Media and IVF Spain websites, social media, etc.). IVF Spain reserves the right to have the final approval before each publication.
- 7. Privacy Policy.** Personal data submitted by the participants is subject to the Privacy Policy stated on the eggdonationfriends.com and IVF Spain Alicante websites. To read them, please click [here](#) and [here](#).

Terms & Conditions:** IVF Spain Alicante S.L. reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the Campaign due to viruses, bugs, non-authorized human intervention, fraud or other causes beyond the control of IVF Spain Alicante S.L. that may corrupt or affect the administration, security, fairness, or proper conduct of the Campaign.
